Walsall Music Education Service (WMES) Photo/Video permissions form

Your privacy and rights matter to us and in order to ensure you are aware of how and why we may take photos/videos alongside storage, please read below before providing your informed and explicit consent (reply slip on page 2).

Walsall Music Education Service (WMES) photographs and videos a range of its activities. Footage may be used for media promotion of the event or future events. This promotion may be made on WMES platforms including our website, YouTube and/or social media channels, as well as printed promotion including flyers and posters. Footage may also be used for promotion from other organisations who are involved in the event.

WMES activities sometimes take place at external/public venues where it is also possible that other 3rd parties unknown to us may take pictures or footage of performers. Please note that WMES cannot prevent photos/videos being taken by members of the public at external venues nor can WMES stop these being posted online.

This form covers all WMES activities and is not exclusive to the groups/activities the student is involved in at the point of signing. This form will be reviewed and updated as necessary. Consent will cover students for all WMES activities until such time. You have the right to change your consent at any point and this must be done in writing to Lizzie Sale (Elizabeth.sale@walsall.gov.uk) or a member of WMES staff.

All photos/videos will be captured on electronic devices such as cameras, voice recorders, video enabled devices or mobile technology. Footage will be securely stored and may be kept indefinitely for both future promotions and archive purposes.

If you wish for footage to be removed, you must inform Lizzie Sale

(Elizabeth.sale@walsall.gov.uk) or a member of WMES management in writing. Once online, WMES can only remove footage it has direct access to and cannot confirm removal of any footage/information shared via social media or otherwise. Where you require the removal of such footage, we recommend you contact the domain or service owner with your request. It should be noted that once online WMES cannot prevent unauthorised downloading of files or photos.
